Hi everyone,

Please find attached the agenda for our call tomorrow. Thank you again Julie for hosting. Quick note – Julie will be on leave for our next call so I will be sending out the Teams Invite for that call in 2 weeks.

As for Atlantis, I did participate in a meeting with the OCIF Commissioner, her lawyers and PR team, and our investigative team today. Lots of discussion back and forth on a variety of issues. There was a good give and take throughout, but in the end, the event is theirs and we are participants, so this is what we agreed to and are moving forward with:

- OCIF did ask us to split the event into two so that they could keep the focus on their announcement, specifically for the island press.
- So we will have one media advisory that I'm working on for the J5 and it will explain that there are two events. One focused on OCIF and one focused on the J5.
- The event will begin at 3pm will feature remarks from the OCIF Commissioner and Chief Jim Lee. Will and Simon will be on the screen live and introduced but will not speak. All media who are interested in covering the event – Puerto Rican media, US, Australian, UK media – all are invited to both events. Questions for the 3pm event will be requested to focus on the action OCIF is taking.
- The second event will start at 3:45. Media from all over the world can be on this call as well, but only questions about the J5 actions will be entertained during this event. Will and Simon will deliver remarks and then all three Chiefs AND the OCIF commissioner will make themselves available for questions at that time.
- I would like to post remarks as prepared for delivery for all three Chiefs on the J5 website.
- OCIF has added some language for consideration to use in our press release. I have attached an updated version here and included Simon's quote and also a place for the OCIF Commissioner's quote.
- We need to go through this release during our call. OCIF will put out their release AND our release Thursday. Both will be in English and Spanish, so we need to allow for time for translating. I'd like to lock the release down Tuesday. OCIF's release is also attached here. This is also draft.
- The two attached press releases are STILL DRAFTS -

Lots of moving parts here guys – lots to talk about.
